



What is Intellectual Property?



Trademarks

Whether you're protecting your brand name, company name, product name...this is a unitary right that lasts for life!

Design Rights

There are three types:

Unregistered (lasting between 3-15 years), Registered (lasting 25 years) and Supplementary (lasting up to 3 years)

Copyright

Lasts for life plus 70 years from the date of creation, occurring automatically

Patents

Used for inventions or an inventory/novel step. Typically last for 20 years.

Trade Secrets

Your company know how! Lasts forever.

CAMPAIGNING - We speak to Government, key influencers & policy makers to ensure that the best possible IP enforcement framework is in place to allow IP creators' ideas to be monetised to achieve growth.

KEY MILESTONES - ACID has achieved much from 25 years of campaigning, from the 2014 IP Act – making the intentional infringement of a Registered Design a crime, to its involvement in many thousands of mediations and settlements. But there's more on our list...



ACID's Campaign Focus

Brexit - Ensure post Brexit, UK designers will not be disadvantaged by losing the benefits of EU Unregistered Design

Enforcement - Extend criminal provisions for the intentional infringement of unregistered designs (in line with registered designs)

3D Printing - whilst there are enormous opportunities there are also IP challenges - as the majority of UK designers rely on UDR, currently not a criminal offence, this leaves the door open (potentially) for organised crime.

Cost, time and stress of taking legal action - Despite improvements to the IPEC and Small Claims Track, it is cost prohibitive for most micro and SME designers to pursue infringement. This needs to change!








LEGAL ADVICE

Free period of initial IP related legal advice (around 1 hour, depending on issue, for each separate issue/ subject). If you need legal advice, follow the link in your Member Hub and you can select a legal affiliate team to offer you free initial advice and receive special ACID Member rates should you need to instruct a lawyer. IP lawyers can charge between £200-400/hour so very worthwhile.

NEW WEBSITE

Member Hub - All you need is here, billing information, downloads, Member Area and much more. Your own personal record where you can add users to your team and remove when necessary.



LEGAL AGREEMENTS



Downloadable legal agreement templates - from Confidentiality agreements to Licence agreements, we offer a range of downloadable templates which can be purchased from the website. Why not take a look and use your automatic Member discount? Your purchased templates can be accessed from your Member Hub for you to redownload at any time.

IP DATABANK

ACID IP Databank - You can upload your important documents, designs and images of your 2D or 3D designs and view them in your Vault. All members were given 3 upload credits on the launch of the new website. We have also increased the file size limit so you can upload more.

1 credit is £1.50 and allows 10 x 5MB files to be uploaded at once. Individual PDF files can contain many images or documents – no restriction if they are under 5MB.

INTELLECTUAL PROPERTY STRATEGY REVIEW (IPSR)

ACID members have found that an IPSR can identify IP issues of which they were previously unaware and provided a focus for solutions. An independent IP audit could cost £5000!
